

De-reservation proposal of reserved vacancies should be dealt with in terms of DOP&T O.M. No. 36020/2/2007-Estt (Res) dt. 07.12.2009 (Copy enclosed). The National Commission for Scheduled Tribes, New Delhi has taken an adverse notice of a case wherein instructions for processing of promotions of unreserved candidates against reserved vacancies were effected without awaiting due approval for de-reservation from the appropriate authority, and action was taken prematurely based on a communication not addressed to OFB.

- O2. As all the units/factories are aware, instructions for processing of de-reservation proposals are to be strictly followed in letter and spirit, in terms of extant DOP&T instructions.
- 03. All heads of units are requested to take note that such premature actions are to be scrupulously avoided and ensure strict compliance of the rules and instructions relating to reservation matters.

# BRIEF ON CASE ON PROMOTION AGAINST 5 ST POSTS BY DE-RESERVATION IN THE GRADE OF ASSISTANT IN 2006

Reference: NCST/New Delhi letter No. SD/2/2012/MDEF2/SEPROM/RU-IV dated 26<sup>th</sup> June, 2012 requesting Secretary (DP) and Chairman/OFB to visit the Office of NCST/New Delhi in person on 18<sup>th</sup> July, 2012 and discuss the issue.

- 1. Promotion of 5 UDCs to the grade of Assistant was effected against a proposal of dereservation in the year 2006, although formal approval from the competent authority in this regard was awaited and hence, an error had crept in which is sincerely regretted.
- 2. The position was reviewed in the year 2007 while holding Review DPCs for implementation of G.O.I. orders on 85<sup>th</sup> Amendment of the Constitution towards restoration of inter-se-seniority between reserved category employees & un-reserved category employees in promotional grades of ministerial cadre in OFB HQrs.
- 3. During the review, the promotions effected earlier by de-reservation were also reviewed and negated but all the UR category senior employees could be accommodated against regular UR vacancies.
- 4. In this process, it was ensured that no adverse effect in respect of any ST category employees is made in the respective grades.
- 5. The position was further reviewed in the year 2011 (by holding Review DPCs) while implementing DOP&T O.M. No. 36012/45/2005-Estt.(Res) dated 10-08-2010 (the concept of "Own Merit" in Non-selection posts like Assistant/UDC etc.).
- 6. In the above Review DPCs, position in respect of date of promotion of those 5 UR incumbents (who were earlier promoted against de-reservation proposed in 2006) were changed and the comparative position is indicated below ::-

7. Apart from above information, para-wise reply to the observation made by the NCST/New Delhi is furnished below:-

## Para-2(a)

It is a matter of fact. A mistake was committed which is sincerely regretted.

### Para-2(b) & 2(c)

It is stated that no corrective action could be initiated by OFB on receipt of NCST letter dated 12<sup>th</sup> Oct., 2006 due to inadvertence.

### Para-2(d)

The FAX was sent by O.F. Cell/New Delhi to OFB HQrs/Kolkata for purpose of information regarding progress of the case. However, due to overlook, action was taken on that letter.

### <u>Para-2(e)</u>

To implement the 85<sup>th</sup> Amendment of the Constitution and to extend consequential seniority benefit to the reserved category employees. Review DPC was held in the year 2007 (for the period from 17-06-95 to 2006-2007). The position of those 5 individuals has been elaborated in para 6 above. It can be seen that those un-reserved category employees were occupied ST posts not more than 6 months (in one case it was less than 01 month). In the aforesaid Review DPCs all the ST posts remain unfilled due to non-availability of eligible ST candidate(s) in the feeder grade of UDC.

- 8. In view of the above indicated position, action taken by OFB for filling up the posts relying on a copy of communication issued by Min of Def without awaiting for formal approval may be condoned and the issue may be treated as settled. It is also assured that due care would be exercised in future, so that such lapses don't recur.
- 9. In fine, it is also indicated that as on date 12 nos. of ST posts remain unfilled in the grade of Assistant due to non-availability of eligibles.
