Singh, Village-Rajunathpur, Darogaadahi, Ward No. 19,
P.O.-Baripada, District-Mayurbhanj, Orissa.

Sir,

In inviting a reference to the letter on the
subject cited above, it is to submit herewith that on
3.10.2005 on the complaint of Smt. Kalpana Singh (Petitioner)
Baripada Town P.S. case no. 215, dt. 3.10.2005 U/S 376 IPC
read with Section 3 SC & ST (PA) Act was registered and
investigated into. As prima facie case was well established
against accd. Muchhuru S. Narendra Rout, S/O-Date Shaktikanta
Rout of Tulashi Choura, Darogaadahi, P.S.-Baripada Town,
Dist.-Mayubbhanj, Chargesheet was placed vide C.S.No. 211,
dt. 31.12.2006 U/S 376 IPC/3 SC & ST (PA) Act. The said case
is now subjudiced in the court of Addl. Spl. Judge, Baripada
and the accd. Narendra Rout is facing trial.

On the other hand Smt. Urmila Rout, the mother of
accd. Narendra Rout lodged F.I.R. against Lal Mohan Singh,
the husband of the petitioner vide Baripada Town P.S. case
no. 216, dt. 3.10.2005 U/S 341/325/379 IPC. After due investi-
gation this case was return as Final Report false U/S 341/
325/379 IPC vide F.F.No. 23, dt. 12.2.2006 as the allegation of
Urmila Rout the mother of Narendra Rout was considered to
be an afterthought. and in order to save her son from the
charge of rape to a tribal lady, she hoisted a false case.

The allegation of the petitioner against Dr. Hnati
Mishra of Dist. Hqtr. Hospital, Baripada to a given opinion,
being biased, inconnivance and influenced by the relation
of accd. Narendra Rout is not at all true and is baseless.
Rather the H.O. as opined in a positive manner that possibility
of recent forcible intercourse is suggestive from the presence
of whitish discharge in posterior fornix and multiple abrasio

over her both breasts.

It is a fact that the accd. Mahendra Prasad Rout who happens to be the friend of Lal Mohan Singh (husband of petitioner) was visiting the house of Lal Mohan Singh on regular intervals. On the night of occurrence taking the advantage of absence of Lal Mohan Singh, the accd. Mahendra Rout came to the house of petitioner and forcibly committed rape to her.

Joint Enquiry has already been conducted by Deputy Supdt. of Police, Mayurbhanj alongwith the Executive Magistrate cum Tahasildar, Baripada Sadar and sum of Rs. 50,000/- only has been recommended for compensation to the victim lady.
