Ministry of Development of North Eastern Region vide letter No. 3/8/2014-Coord/DoNER dated 9th February, 2015 has sought comments on draft SFC Memo on North East Sector Development Scheme for Standing Finance Committee on "**Mission Organic Farming North East**".

2. The Proposal was examined and noted that the proposed scheme has been drafted by the Ministry of Development of North Eastern Region. Ministry of Development of North Eastern Region is the sponsoring agency of the scheme and it is noted that the Scheme is for all the States of North East Region are major tribal areas and North Eastern Region being traditionally Organic or near to Organic has tremendous potential for development of organic farming due to two major reasons; (a) mostly rain-fed and hilly in topography and (b) external input use is very low to insignificant (except largely with plains of Assam, Manipur and Tripura). The need for production, value addition and processing under organic protocols with growers as owners ensures better empowerment of rural youth and increases new avenues for rural entrepreneurship.

3. The Commission agreed to the proposal provided there is a special mention about the procedure to be followed for extending the benefits of the scheme to the Scheduled Tribes families or villages in the North East Region.
