
Proceedings of the Sitting chaired by Hon'ble Vice-Chairperson, NCST, Government of India on 27.07.2016 at 03.00 P.M. in the petition filed of Shri K. L. Meena, Deputy director (Air Safety), New Delhi regarding manipulating ST DR post for promotion under promotion quota by DGCA & Ministry of Civil Aviation.

Date of Sitting: 27.07.2016

List of officers present in the Sitting is as at Annexure-1.

Ministry of Civil Aviation, Government of India and Director General of Civil Aviation, Government of India, New Delhi were intimated the recommendations of the hearing held on 26-10-2009 in the National Commission for Scheduled Tribes, under the Chairmanship of the then Hon'ble Vice Chairperson Shri Maurice Kujur vide this Commission's letter dated 16-11-2009. The recommendations as contained in para 16 (ii) and 16(iv) of the proceedings are still required to be complied with by the Ministry of Civil Aviation and Director General of Civil Aviation.

Accordingly, a hearing in this case was again convened on 27-7-2016 at 3.00 PM under the Chairmanship of Hon'ble Vice Chairperson, National Commission for Scheduled Tribes. Secretary (Civil Aviation) and DGCA sought exemption from personal appearance which has been agreed to and they have nominated two Joint Secretary level officers with a request to allow them to attend the hearing which has been allowed by the Chair.

The contention of the applicant was that vacancies meant for Director Recruits under ST quota has been filled up by promotion and by a general category candidate by DGCA by concealing the facts to the UPSC. The Petitioner has also stated that the Department is trying to conceal facts and the actual picture of the entire position regarding the promotions made in DGCA need to be verified for more clarity.

Joint Secretary, Ministry of Civil Aviation and Joint Director General from the Office of Director General of Civil Aviation have submitted that they will show the roster to the Commission within 15 days and any mistake committed shall be corrected. They have also been asked to bring the records pertaining to the promotion case of Shri Manish Kumar (Chopra) to the grade of Deputy Director and subsequently to Director in DGCA.

The hearing ended with a vote of thanks to the Chair.
