Hence, the Hon'ble Vice-Chairperson has decided to discuss the matter in person with you in the Commission on 11.11.2016 at 4.00 P.M.

Please take notice that in case the Commission does not receive reply to attend the Sitting from you within the stipulated time, the Commission may exercise the powers of Civil Courts conferred on it under Article 338A of the Constitution of India and issue summons for the appearance in person or by a representative before the Commission. It is therefore requested you to kindly make it convenient to attend the Sitting in Commission on the Scheduled date and time with all relevant records in the case.
