Whereas a Petition / Complaint has been received by the National Commission for Scheduled Tribes from Shri Tumto K. Lobam & Five Others dated 12/05/2017 and to say that the matter was taken up with the Lt. General S.K. Shrivastava, Directorate of General Border Roads, Seema Sadak Bhawan, Ring Road, Delhi Cantt. New Delhi-110010 vide this Commission's letter dated 17/05/2017. In response to this Commission's, letter mentioned above and to say that the Chief Engineer, Directorate of General Border Roads, New Delhi has intimated that the subject case is being duly assessed and is under consideration for release of additional compensation as per rules & Regulation of the Govt. of India financial framework. They have also informed that final action taken report on release of addl. compensation of funds would be intimated accordingly. It is mentioned here that this Commission has also sent two reminders to the concerned authority on 20.06.2017 and 28.07.2017 and also endorsed a copy of letters to the petitioner. No reply has been received from the concerned authority on the subject matter in the Commission so far.

Hon'ble Member (HKD), NCST has desired to discuss the matter in person with them and accordingly fixed a Sitting on 25.09.2017 at 3.30 P.M. in the Commission at Conference Room, 6<sup>th</sup> Floor, Loknayak Bhawan, Khan Market, New Delhi for investigation/inquiry/action taken in the matter in pursuance of the powers conferred upon it under Article 338A of the Constitution of India.
