Minutes of sitting held in the Commission on 08/09/2017 at 12:00 Noon under the Chairmanship of Shri H. C. Vasava, Hon'ble Member, NCST in the case of Shri O. P. Gaud, R/o 47, Type-III, Jal Vihar Colony, Lajpat Nagar-I, New Delhi-110024 regarding harassment, victimisation and dismissal from service.

Representation dated 10/04/2017 received from Shri O. P. Gaud, R/o 47, Type-III, Jal Vihar Colony, Lajpat Nagar-I, New Delhi-110024 regarding harassment, victimisation and dismissal from service.

The matter was taken up with the Chief Executive Officer, Delhi Jal Board vide Commission's letters dated 12/05/2017 followed by a 28/06/2017. Shri H. C. Vasava, Hon'ble Member, NCST has fixed a sitting with the Delhi Jal Board to discuss the matter on 08/09/2017 at 12:00 Noon.

Discussion:

Shri H.C. Vasava, Hon'ble Member, NCST asked the petitioner to submit his grievances. Shri Om Prakash Gaud has stated that he was appointed as Junior Engineer during the year 1991 and promoted as Assistant Engineer in 1998 in Delhi Jal Board. The petitioner also submitted that his caste certificate bearing No. 1075 dated 17/12/1980 which was issued by Shri G. D. Joshi the then Naib-Tehsildar/Executive Magistrate in Indore, Madhya Pradesh. The Delhi Jal Board duly verified and satisfied with the authenticity of the caste certificate of the petitioner.

2. He also informed that he has raised some corruption issues of Officers in Delhi Jal Board during the year 2007 to 2012 in the interest of the Department / public exchequer. After that the Vigilance Department of Delhi Jal Board issued a Memo to the petitioner about his fake caste certificate and asked to submit the same in original to the Department. The petitioner has stated that the original caste certificate was submitted to the Delhi Police in a Court Case and he was not in the position to submit the same to the Department.

3. Shri H. C. Vasava, Hon'ble Member asked the Jal Board Shri Keshav Chandra, CEO, Delhi Jal Board to explain his opinion on the current case. Shri Chandra assured the Commission that if Shri Om Prakash Gaud submit his original caste certificate to the Department then his case will be considered sympathetically after the submission of the same. The Hon'ble Member has then advised the petitioner to submit his caste certificate issued by the Competent Authority **within 30 days** to the Delhi Jal Board.
