

**Minutes of meeting of Principal Secretary (Home), Govt of Rajasthan with
Hon'ble Chairperson, NCST in her chamber on 07.02.2008 at 2.00 pm.**

ISSUES

1. The assistance of Rs. 5.00 Lakh to Smt. Shanti devi w/o Late Ram Lal a ST youth killed in police firing on 08.02.2007 at Rishabhdeoiji, Distt. Udiapur and a Govt. job to one of the family member at par with other General category people.
2. Provision of basic facilities like school, community center, electricity, water, dispensary, roads etc. in village Banganga, Teh. Atru, Distt. Baran, Rajasthan where residents are mostly from ST category.

BACKGROUND

1. A representation from Gen. Sec. RPCC was received on 10.03.2007 that while in the case of Gen. Category people who were killed in Police firing, a compensation of Rs 5.00 Lakh was granted by the State Govt., in the case of a ST youth, Late Ram Lal S/o Shri Phoolaji Meena R/o Village Dhelana, Distt. Udaipur, who was killed in police firing on 08.02.2007, a compensation of Rs. 1.00 Lakh only was granted. Therefore, he has requested that compensation of at least Rs. 5.00 Lakh to be given to the family of Late Ram Lal and employment to one member of the family should also be given at the earliest.
2. A representation from residents of Village Banganga was received in the Commission on 01.08.2005 that Administration is not providing basic facilities in their village.

DELIBERATIONS

It was intimated by the Principal Secretary (Home) Govt. of Rajasthan that an amount of Rs. 5.00 Lakh has already been paid to the family of Late

Ram Lal and Smt Shanti Devi w/o Late Ram Lal has been appointed as Sahayika in the Aanganwadi Centre.

Shri Ashk Ali Tak mentioned that as an immediate measure of relief, appointment of Smt. Shanti Devi as Sahayika was acceptable, but she should be considered for some permanent job in some Govt. Department. He also intimated that there are 2-3 Govt. Offices at a distance of 2 Km from the village, where she could be considered for appointment.

Shri Ashk Ali Tak also intimated that in the same police firing some 11 ST people were also injured and 3 have become permanent disabled. The compensation given to them is of Rs. 10,000, which is not sufficient.

Shri Singh intimated that compensation to the injured are given on the basis of medical report. However, he assured to have the matter re-examined.

Representation received from ST villagers of Banganga was sent to DM, Baran, whose reply is not satisfactory for villagers and reality is different from what is mentioned in the reply.

DECISIONS

1. It was decided that possibility to provide a job in the nearest Govt. Office to Smt. Shanti devi to be explored subject to her convenience, as she has to look after her 4 children also.
 2. Govt. of Rajasthan will get the medical report of 11 injured re-examined, so that proper compensation can be given.
 3. Govt. of Rajasthan will do all possible efforts to provide basic facilities in the Village Banganga and provide a feedback in these matters within one month.
