**Issue :**

Representation dated 11/01/2011 from Shri A. Ranjit Naik, F/o Shri A. Rahul Kumar Naik, B.Tech (Bio-Tech) Roll No. 6837 regarding delay in declaration of results of the 7<sup>th</sup> & 8<sup>th</sup> Semester's examination of final academic year 2009-10.

**Background:**

Shri A. Ranjit Naik represented on 11/01/2011 to the Commission regarding non-declaration of results of 7<sup>th</sup> & 8<sup>th</sup> Semester's examination of final academic year 2009-10 in respect of his son- Sh. Rahul Naik, B.Tech (Bio-Tech). Prior to his representation, Shri A. Ranjit Naik also submitted a copy of the letter



to the NCST on 14/12/2010 regarding the correspondence made between Sh. M. Venkata Ramana Rao, Hon'ble Minister of Law, Court Technical Education and ITI's addressed to Shri Kapil Sibbal, Hon'ble Minister of HRD & Chairman NITs Council in the matter. NCST, vide letter dated 24/12/2010, had sought comment of the Secretary, Ministry of Human Resources Development on the subject. As no reply was received from the Ministry of Human Resources Development, a d.o. letter dated 13/01/2011 was issued from the Hon'ble Chairperson, NCST to Shri Kapil Sibbal, Hon'ble Minister for Human Resources Development bringing to his knowledge the facts of the case about reported harassment meted out to Mr. A. Rahul Kumar Naik (who belonged to a ST community of Andhra Pradesh) due to non-declaration of the results and consequent denial to the admission of Mr. A. Rahul Kumar Naik to post graduate course.

Vide letter dated 14/01/2011, the Secretary, Department of Higher Education, Ministry of HRD and Director, NIT Warangal were asked to appear before the Commission on 21/01/2011 at 12 00 hours for discussion in the case with all relevant records. The Ministry of HRD, vide letter dated 18/01/2011 informed the Commission that Secretary, HRD, had to attend another meeting, which was fixed earlier at the level of the Hon'ble HRM, at the scheduled date / time of the meeting fixed by the Commission. With the permission of the Hon'ble Chairperson, the Ministry of HRD was represented by Shri. N.K. Sinha, Addl. Secretary, Higher Education in the meeting.

**Discussion:**

Sh. N.K. Sinha, Addl. Secretary, M/o HRD and Prof. V. Ramarao, Director, NIT Warangal appeared before the Commission. The Commission desired to know the reasons for non-declaration of the results of the 7<sup>th</sup> & 8<sup>th</sup> Semester in

respect of Shri A. Rahul Kumar Naik, while he was allowed to appear in the 7<sup>th</sup> and 8<sup>th</sup> Semester by the competent authority of NIT Warangal.

The position presented by the Director, NIT Warangal was not found satisfactory as it revealed that the relevant records were not examined with circumspection. The Addl. Secretary, M/o HRD also did not find the explanation by the Director, NIT Warangal satisfactory and justified. After detailed discussion, the Commission desired that the Director, NIT Warangal should submit factual position in the matter, with relevant records, specifically with reference to the following in the next meeting of the Commission, which will be held on 02/02/2011 at the Commission:

- (1) The reasons for withholding results of the examination of Sh. A. Rahul Kumar Naik..
- (2) Position on whether Sh. A. Rahul Kumar Naik has passed or failed in the examination.
- (3) Why delay in declaration of the results of the examination in respect of Shri Rahul Kumar Naik, having permitted him to appear in the examination, shouldn't be treated as harassment to him.

The meeting was held in pursuance of the decision taken in the Sitting taken by the Hon'ble Chairperson on 21.01.2011 in connection with the representation dated 11/01/2011 from Shri A. Ranjit Naik, F/o Shri A Rahul Kumar Naik, B.Tech (Bio-Tech) Roll No. 6837 regarding delay in declaration of results of the 7<sup>th</sup> & 8<sup>th</sup> Semester's examination of final academic year 2009-10.

In the aforesaid Sitting, the Commission had desired that the Director, NIT Warangal should submit factual position in the matter, with relevant records, specifically with reference to the following:

i.	The reasons for withholding results of the examination of Sh. A. Rahul Kumar Naik..
ii.	Position on whether Sh. A. Rahul Kumar Naik has passed or failed in the examination.
iii.	Why delay in declaration of the results of the examination in respect of Shri Rahul Kumar Naik, having permitted him to appear in the examination, shouldn't be treated as harassment to him.

It was explained by the Director, NIT, Warangal that the case would be submitted to Senate and thereafter, it would be placed before the meeting of the Board of Governors (BoG) on 11.2.2011. In the aforesaid meeting of the Senate, Prof. S.S. Gokhale who was Director, with additional charge of NIT Warangal, will also be invited because he was connected with the subject case and permitted the candidate to provisionally appear in the examinations of the 7th & 8th Semester, with the condition that the case would be subsequently reviewed under the prevailing academic rules of the Institute before final decision in this regard was taken

Additional Secretary, HRD mentioned that the agenda note before the Senate should be comprehensive and include factual position of the whole case including various permissions approval granted to Rahul Kumar Naik for attending the Seminars, industrial training, project work as a part of the 8<sup>th</sup> semester curriculum.

Hon.ble Chairperson also desired that the nature of issues raised by the applicant- Sh. A. Ranjit Naik should also be given due consideration in the

agenda note to be submitted before the Senate. After detailed discussion, Director NIT Warangal assured the Commission that the applicant Sh. A. Ranjit Naik may again refer the issues, which in his opinion required consideration of the Senate. These issues will also form a part of the agenda, with the comments of the NIT Warangal. Director, NIT Warangal also informed the Commission that an opportunity would also be extended to Sh. A. Ranjit Naik for presenting his son's case before the Senate for consideration. The recommendations of the Senate would be submitted to the Board of Governors for final decision in the matter. Director, NIT Warangal also informed that a copy of the agenda note would also be forwarded to the Commission and it would be ensured that the case, with the recommendation of Senate, is positively submitted to the BoG in its ensuing meeting scheduled to be held on 11.02.2011
