Sir,

I am directed to refer to this Commission's letter of even No. dated 23/02/2012 (copy enclosed) on the subject mentioned above and say that Dr. Rameshwar Oraon, Chairperson of the National Commission Scheduled for Tribes has desired to discuss the case with the Superintendent of Police Jaipur,(Rural) on 13/03/2012. Accordingly sitting was fixed on 13/03/2012 for discussion in the Commission. The Commission noted with concern that the Superintendent of Police who was called for discussion in the case of Shri Sube Singh Meena, did not appear nor sent any communication to N.C.S.T. The A.D.M. Kotputli, Jaipur Shri Vishamber Lal from the office of the District Collector who appeared before the Commission on 13/03/2012 was asked to inform the S.P Jaipur, (Rural) of his non appearance in the matter.

The Commission has observed that tribal land matter required to be discussed and Dr. Rameshwar Oraon, Chairperson of the N.C.S.T. has now fixed a sitting with you in person on 15/05/2012 at 13.00 hours in the Commission.

I am, therefore, to request you to kindly make it convenient to attend the above sitting in the Commission at the scheduled date and time alongwith the Superintendent of Police Jaipur, (Rural) with complete information and records relating to the case.
