Sub Review of Constitutional Safeguards for Scheduled Tribes. Monitoring of Reservation Policy and Development Programmers/Schemes implementation for Scheduled Tribes by the Maulana Azad National Institute of Technology (NIT) Bhopal.

The National Commission for Scheduled Tribe visited NIT Bhopal on 17/18 -12-2017 for reviewing of Constitutional Safeguards for Scheduled Tribes, Monitoring of Reservation Policy and Development Programmers/Schemes implementation for Scheduled Tribes in the Maulana Azad National Institute of Technology (NIT) Bhopal. During the review meeting, some PG students of ST community represented to the Commission that they are required to pay full tuition fees and whereas another NITs, ST students are not required to pay the tuition fees. Since many students are affected on this decision of NIT, which according to NIT Bhopal have taken as per instructions of Ministry of Human Resource Development.
