Sub: **Review and monitoring of Implementation of Reservation Policy and Constitutional safeguards for Scheduled Tribes in Allahabad Bank.**

Sir,

The National Commission for Scheduled Tribes (NCST) has been constituted under Article 338A of the Constitution, is vested with responsibility, inter-alia, to investigate and monitor all matters relating to the safeguards provided to the Scheduled Tribes (STs) under the Constitution or under any other law for the time being in force or under any order of the Government and to monitor and evaluate the working of such safeguards. The Constitution also enjoins the Commission to evaluate the progress of development of STs under Union. The Commission is required to present to the Hon'ble President of India annually and at such other times as the Commission may deem fit, reports upon the working of those safeguards.

2. Accordingly, the Commission has decided to review the implementation of reservation policy and constitutional safeguards including various issues affecting ST employees with the Allahabad Bank and representatives of ST Employees Welfare Association in Allahabad Bank tentatively in the 2<sup>nd</sup> week of December, 2018 at its Hqrs, Kolkata. The detailed Tour Programme is being finalized and will be intimated shortly.


The Commission has evolved a questionnaire for review and a copy of which is enclosed for furnishing replies/information by your organization. The questionnaire can also be down loaded from NCST Website <http://ncst.nic.in/content/questionnaire-review-download>. The replies to various issues covered under the questionnaire will form the basis for review meeting. It is requested to make a power point presentation on the subjects mentioned above to facilitate discussion.

4. It is requested that the replies/information in respect of questionnaire may be sent to this Commission **before 10.12.2018** positively. A soft copy of the replies to the questionnaire may also be sent to [jsncst@nic.in](mailto:jsncst@nic.in) and [ds.admn@nic.in](mailto:ds.admn@nic.in)/[bansal.yk@ncst.nic.in](mailto:bansal.yk@ncst.nic.in) for record.
