**Sub Review and monitoring of Implementation of Reservation Policy and Constitutional safeguards
 : for Scheduled Tribes in Kamarajar Port Ltd. under the Ministry of Shipping.**
 Sir,

The National Commission for Scheduled Tribes (NCST) has been constituted under Article 338A of the Constitution, is vested with responsibility, inter-alia, to investigate and monitor all matters relating to the safeguards provided to the Scheduled Tribes (STs) under the Constitution or under any other law for the time being in force or under any order of the Government and to monitor and evaluate the working of such safeguards. The Constitution also enjoins the Commission to evaluate the progress of development of STs under Union. The Commission is required to present to the Hon'ble President of India annually and at such other times as the Commission may deem fit, reports upon the working of those safeguards.

2. Accordingly, the Commission has decided to review the implementation of reservation policy and constitutional safeguards including various issues affecting ST employees with the Kamarajar Port Ltd. and representatives of ST Employees Welfare Association in Kamarajar Port Ltd. in its Hqrs, Chennai (Tamil Nadu) on 1st week of June, 2019. The detailed Tour Programme is being finalized and will be intimated shortly.
3. The Commission has evolved a questionnaire for review and a copy of which is enclosed for furnishing replies/information by your organization. The questionnaire can also be down loaded from NCST Website <http://ncst.nic.in/content/questionnaire-review-download>. The replies to various issues covered under the questionnaire will form the basis for review meeting. It is requested to make a power point presentation on the subjects mentioned above to facilitate discussion.
4. It is requested that the replies/information in respect of questionnaire may be sent to this Commission by 30th May, 2019. A soft copy of the replies to the questionnaire may also be sent to jsncst@nic.in and ds.admn@nic.in/bansal.yk@ncst.nic.in for record.
