
I am directed to refer to National Commission for Scheduled Tribes (NCST), letter of even No. dated 14.11.2022 addressed to Sardar Vallabhbhai Patel National Police Academy (SVPNPA), Hyderabad on the subject cited above. It is pertinent to mention that the questionnaire sent by the NCST with the above letter was not found suitable for the Academy. Hence, the NCST has revised the questionnaire for Review for implementation of various safeguards and programmes for development of STs in Academy/ Institution, a copy of the revised Questionnaire is enclosed.

2 Replies / information in respect of questionnaire may be prepared and furnished (Two copies) to this Commission **within 15 days** from receipt of the letter. A soft copy of the replies to the questionnaire may also be sent to js@ncst.nic.in/director@ncst.nic.in for record. A brief presentation along with measures / programmes taken up by SVPNPA for welfare of Scheduled Tribes in the country may also be made during the review meeting before the Commission. The date of review meeting is tentatively **fixed in the first week of January, 2023.**

3 The Commission will also discuss the issue of grievances of Scheduled Tribes employees of SVPNPA with association of ST employees of SVPNPA before the review meeting. The association of ST employees of SVPNPA may be asked to attend the meeting. The Liaison Officer for STs in SVPNPA may also be asked to attend the meeting with association of ST employees of SVPNPA and review meeting.

4. It is therefore, requested that the requisite information may please be sent to the NCST at the earliest, for examination and for fixing the date, time and venue of the Review Meeting.
